DETAILS:

13 On Thursday, March 8, 2018, I assisted Central Homicide Unit (CHU) Inv. Johnson with an Officer Involved
14 Shooting incident that occurred at 9931 Willowbrook Rd., Jurupa Valley, CA. My assignment was to manage
15 the charting of the Riverside Police Department officers involved with the shooting. This report reflects the
16 charting of RPD Officer Robert Monreal.
17

18 The charting of Officer Monreal took place in the Community Room within the lobby of the Jurupa Valley
19 Sheriff's Station. Present for the charting was Riverside County Sheriff's Forensic Technician Jane Muschell,
20 who photographed process.
21

22 The charting process started at 12:38AM. Forensic Technician Muschell photographed Officer Monreal's
23 clothing to memorialize the condition of his uniform at the time of the shooting. He wore (from head to toe)
24 a black t-shirt under a black load bearing (LBV) vest with various pouches sown onto it. The vest had a cloth
25 RPD badge sown on the left chest, a black name tape with R. MONREAL and a name tape that read POLICE
26 sown onto the right chest. The back of the LBV had a display patch that read POLICE adhered to it. He wore
27 a black nylon uniform belt with a triple magazine pouch, a pair of gloves hanging from a carabineer, a quick
28 response medical pouch, a thigh holster with one leg strap. A tourniquet was mounted to the holster mount.
29 He wore green BDU pants and black boots.
30

31 At the time of the charting, Officer Monreal's uniform belt was photographed on a sheet of butcher paper. The
32 belt contained (from left to left) a triple magazine pouch with three steel Mec-Gar 8-round handgun magazines
33 inserted in it, a black nylon dump pouch folded up, pair of black/green gloves hanging from a carabineer, a
34 quick response medical pouch, and a handgun holster with one thigh strap for a Springfield Armory 1911, .45
35 caliber, semi-automatic pistol (s/n: NM490105), with a mounted Streamlight TLR-1 HL flashlight.

37 The firearm was loaded with one live round in the chamber and loaded with ten live rounds in a 10-round Mec-
38 Gar steel handgun magazine. Each of the three steel Mec-Gar magazines in the magazine pouch contained
39 eight live rounds. Thirty-five rounds were accounted for on the duty belt. Each of the rounds had a head stamp
40 that read WINCHESTER 45 AUTO. Officer Monreal explained he did not fire his handgun, and he loads his
41 magazines to capacity.
42

43 Next, Officer Monreal's LVB was charted. It was removed and placed on a sheet of white butcher paper. The
44 contents of the vest were exposed and recorded. The vest housed a handheld radio and microphone, a digital
45 recorder, a pry bar, an AR15 magazine, and a steel Mec-Gar 8-round handgun magazine.

46 The AR15 magazine was not charted because Officer Monreal did not carry a weapon for that magazine. The
47 steel Mec-Gar 8-round magazine was charted, and it held eight live WINCHESTER 45 AUTO rounds.

3 The charting process revealed Officer Monreal carried forty-three rounds on his duty belt. All of Officer
4 Monreal's rounds are accounted for.

5 Officer Monreal did not activate his digital recorder before or during the incident. Therefore, it was not
6 collected or examined.

7 The charting process ended at 12:54AM, and Officer Monreal left the room. A short time later, he met with
8 Inv. Johnson and an interview was conducted.¹ The charting process concluded after Officer Monreal's
9 charting.

10 This concluded my activity with the charting of the Riverside Police officers. I continued assisting with the
11 investigation and helped Inv. Johnson with interviewing Lisa Castillo.²

12 This is an open investigation and this report's status reflects such. A copy of this report was incorporated into
13 the investigation file managed by Investigator Johnson.
