DETAILS:

On Thursday, March 8, 2018, I assisted Riverside County Sheriff Department Central Homicide Unit Investigator Anthony Johnson with an Officer Involved Shooting incident at 9931 Willowbrook Road, Jurupa Valley, CA 92509. As part of my responsibilities, I was assigned to interview Stephanie Rocio at the Jurupa Valley Sheriff Station.

[REDACTED] and I met in the break room within the Jurupa Valley Station. She was there because her young children were relaxing on the sofa and watching television. At the onset of the conversation, [REDACTED] provided her biographical information, as well as the biographical information for her children. She also identified her husband as [REDACTED] and admitted they live at [REDACTED]

[REDACTED] was asked about the incident earlier in the evening and she explained she did not know what happened in the garage. She recalled being in the living room doing homework with the children. One of her son's returned from the kitchen with an apple and as soon as that child sat down, they heard gunfire coming from inside the garage.

[REDACTED] responded to the noise and scurried the children into the back of the house and hid (with the children) in the closet. As soon as she heard the gunfire, she feared someone was there to hurt them, so she ran the children into the rear of the house. After the gunfire, and waiting for a short period, [REDACTED] exited the back bedroom and engaged an officer. She informed the officer her children were hiding in the back bedroom and she was instructed to get them and exit the house.

While speaking to the officer, [REDACTED] saw [REDACTED] cousin Ernie Saldivar laying on the floor in the hallway leading from the kitchen to the garage. [REDACTED] then collected her children and escorted them out of the house and into the front yard. She remained in the front yard until she, and the children, were transported to the Jurupa Valley Station.

As we spoke about the events leading to the shooting, [REDACTED] recalled [REDACTED] Ernie and [REDACTED] were inside the garage talking. She explained Ernie is [REDACTED] cousin, but did not know the family connection. She also knew [REDACTED] was [REDACTED] mother's sister, and she came over to visit and interact with the children. [REDACTED] added Ernie came to their home to help them move into the home and he spent the night a few nights

as they moved furniture around the home and situated their personal property.

3 [REDACTED] added [REDACTED] was supposed to take Ernie to a family member's house, but when [REDACTED] arrived at
4 the house, no one was home. Therefore, [REDACTED] brought Ernie back to their home and stayed with them. She
5 remarked Ernie was supposed to leave the house the following day (2/9/2018).

6 [REDACTED] did not know of any weapons inside the house and knew [REDACTED] did not have any. She did not
7 know if Ernie possessed any firearms while he was at their home.

8 [REDACTED] did not know Ernie well, and did not know the police were looking for him. She added she met him
9 a few months earlier. [REDACTED] introduced them and told [REDACTED] that Ernie was recently released from jail.
10 She also commented Ernie stayed away from the children and was respectful around the children. She knew
11 he spent most of his time in the garage and only came into the house to sleep. She also felt it was strange that
12 Ernie did not communicate with anyone and did not have a girlfriend. [REDACTED] could not provide any
13 additional information about Ernie or the circumstances that lead to the police coming to their home.
14

15 At the end of the conversation, [REDACTED] was provided my contact information and encouraged to contact me
16 if she recalled anything that was pertinent to this investigation.

17 This is an open investigation and this report's status reflects such. A copy of this report was incorporated into
18 the investigation file managed by Investigator Johnson.
