Narrative of Supplemental Report:

On 11/1/08, I received a request from Sergeant M. Rossi to attend the autopsy of Marlon Acevedo. On 11/3/08, at 1042 hours, I arrived at 800 South Redlands, Perris (Riverside Sheriff-Coroner Morgue). I contacted Detective Rick Cobb, who told me what evidence items to collect. At 1115 hours, the autopsy began. The autopsy was attended by Det. R. Cobb, Deputy District Attorney M. Paradise, Forensic Pathologist S. McCormick, Forensic Technician G. Wilson and Coroner Technician T. Ayon. I took (171) digital photographs of the autopsy. The autopsy concluded at 1326 hours. At 1345 hours, I took possession of Evidence Items #A1-A13 from For. Tech. G. Wilson. Refer to the Photo Log and Property Report. At 1350 hours, I cleared the morgue and transported the evidence items to the Magnolia Station. At 1530 hours, I secured Items #A1-A13 in the evidence vault. I downloaded the photographs to a secure file format.

On 11/4/08, I released Evidence Items #A1-A13 to Magnolia Station Police Property Specialist K. Duncan. No further action was taken.
