On 11-01-08, at approximately 0100 hours, Evidence Technician McKay-Davis and I responded to Parkview Community Hospital to examine S-Acevedo who was deceased.

S-Acevedo was lying in an examination room in the E.R. He had medical tubes and equipment attached to his body.

Deputy Coroner Clark arrived and a brief examination of S-Acevedo was conducted.

S-Acevedo had one taser barb attached to his stomach area. A red mark was next to the attached taser barb, approximately three inches away. This is possibly the location of where the second taser barb struck S-Acevedo, but fell out. The second taser barb was found in his pants which were cut by medical personnel.

The taser cartridge was next to the leg of S-Acevedo.

The following injuries were visible during the examination of S-Acevedo:

- Abrasion over left eye brow.
- Abrasion near right eye.
- Abrasion near right eye brow.
- Baton bruise to left thigh area.

Evidence Technician McKay-Davis photographed S-Acevedo.
