62. Narrative of Supplemental Report 62a. Audio Recording Available? <b>No</b> On February 18, 2012, at approximately 1445 hours, I monitored a radio transmission from Sgt. McCoy (Sam-63) of "Shots Fired." I began responding and learned the Metro Team had been in the area of Harold and Philbin conducting a surveillance when an officer-involved shooting occurred. I arrived on scene and met with Lt. Phillips who was the Incident Commander. He told me Sergeants Whitt and McCoy were the involved officers and needed to be transported from the scene to the Magnolia Station. I contacted Whitt and McCoy and escorted them from the scene to my police unit parked at the corner of Philbin and Harold. I reminded them they are not to discuss the incident and transported them to the Magnolia Station. When we arrived, I was joined by Sgt. Brian Smith and Officer Kevin Kauk. The involved supervisors and witness officers were separated. I stayed with Sgt. Whitt until Detective Dave Smith arrived at the station and eventually conducted interviews.
