Background:

On February 18th, at about 1445 hours, I was assigned to the City of Riverside METRO Team. We were attempting to serve an Arrest Warrant for S/Bond, Danny. Det. Rowe interviewed me about this incident. See his report for further. During the incident, I spoke to several witnesses who I contacted in front of 5664 Harold Street.

Narrative:

I contacted W/Hernandez, Pedro in the driveway of 5664 Harold Street. I spoke to him briefly about what he saw. He told me he saw S/Bond traveling north bound on Harold Street on a bicycle. He said a Police Vehicle was following S/Bond. S/Bond got off of his bike and opened his jacket and reached for something. He did not see what it was. He simulated the movement by reaching with his right hand into his right-side front waist band. He said he then heard several gunshots. He told me he did not know or recognize S/Bond. I recorded W/Hernandez's statements on my Department Issued Voice Recorder. W/Hernandez was interviewed at greater length by Detectives afterwards. See their reports for further.

I also briefly spoke to W/Ortega, Hugo and W/Ayon, Marco. Both subjects spoke Spanish. I requested a Spanish speaking Officer to respond and speak to them. I was relieved by responding units. See additional reports for further.
