**Narrative:**

I was contacted by Sgt. Ron Whitt on 2-20-12 reference the interview he gave to Detective Dave Smith and I on 2-18-12. Sgt. Whitt told me he had been reflecting back on the interview and felt he needed to clarify a statement he made about making eye contact with S/ Danny Bond. Sgt. Whitt advised he was taking a few days off and would be back the following week. We scheduled an interview for 3-1-12 at the Magnolia Station.

On 3-1-12 at 1135 hours Detective Smith and I re-interviewed Sgt. Whitt at the Magnolia Station. Sgt. Whitt advised that he wanted to clarify a statement made in the original interview and he did not need his attorney present. Sgt. Whitt stated he had been thinking about the shooting and interview. Sgt. Whitt recalled during the interview he told Detective Smith and I that he looked into S/ Bond's eye's as S/ Bond looked back at him. Sgt. Whitt also said during his interview that S/ Bond and he were wearing sunglasses, which would have made it hard for them to have literally made eye contact. Sgt. Whitt said he didn't mean, when he said they made eye contact, that he actually looked into S/ Bond's eyes or that he saw the whites of his eyes. Sgt. Whitt wanted to clarify that S/ Bond and he didn't take there sunglasses off prior to the shooting and look into each other's eyes. He was referring to the look that S/ Bond gave him when he turned to his left and looked over his shoulder. Sgt. Whitt said S/ Bond's facial expressions were very deliberate and committed. Sgt. Whitt said he can tell when someone is looking at him even if he can't see the person's eyes. Sgt. Whitt said it was hard to describe a snapshot of that moment and what the look was on his face, but he knew S/ Bond was looking back at him to try and locate where he was. Sgt. Whitt said based on everything he knew about S/ Bond leading up to that moment, the movement to his waistband with his right hand and the looking back at him, there was no doubt in Sgt. Whitt's mind that S/ Bond was about to shoot him or Sgt. McCoy.

13 Q: All right this is, uh, Detective Rowe. Um, I'm here with Sergeant Ron Whitt  
14 and Detective (Dave) Smith. Um, we're here to, uh, Sergeant Whitt had  
15 contacted me reference the officer-involved shooting. And he wanted to clear  
16 up, um, a statement that he had made during that interview, um, reference,  
17 um, when he made conta- eye contact with the, uh, the suspect. Uh, it's  
18 March 1 at about 1135 hours. All right, um, you - you had contacted me on  
19 the phone, um, a couple days after the interview. Um, and so, um, what is it  
20 that you wanted to clarify as far as your statement, uh, or your original  
21 statement?

22  
23 A: Uh, just, uh, when we spoke Saturday evening after the incident, um, just  
24 kinda reflecting back on that, um, I called ya Monday morning on the 20th  
25 just to make sure - I know I told ya during the interview what he was wearing,  
26 that he had sunglasses. Uh, but also during the interview, I wanted to make it  
27 very clear that we - there was a look exchanged. And I think during the  
28 interview I used, "We made eye contact." Um, I had sunglasses on. The  
29 suspect had sus- uh, sunglasses on, as well. So I just wanna make sure that,  
30 you know, none of that had changed. The sunglasses didn't come off and get  
31 put back on or anything like that. Uh, but there was a - a definitive look that  
32 we exchanged. Uh, I didn't see the whites of his eyes or anything like that.  
33 But he looked back and me. And - and I'm trying to describe a snapshot of a  
34 moment, uh, you know, in - in a video, if you will. Um, so I just wanted to  
35 make sure that it was clear. He had sunglasses on the entire time. I had  
36 sunglasses on the entire time. But there was, uh, a - a definite moment when  
37 he looked over his shoulder. And, you know, in looking back at that, it - it's -  
38 it's my feeling, um, going and reviewing that in my head that - that, you  
39 know, it was an attempt probably to see where I was at, um, you know, that -  
40 that he might have been tracking my movement, um, because, uh, it was a real  
41 deliberate look over his - his left shoulder. And then there was that moment  
42 where, you know, we looked at each other and - and, uh, you know, uh,  
43 shortly after that the shooting occurred.

45 Q: So when you described, uh, making eye contact with him or - or looking to -  
46 during - during the interview, you had mentioned that, uh, a couple a times.  
47 Um, the eye contact wasn't a literal meaning that you guys seen each other's  
48 eyes. That was basically a - a - you were describing, uh, the facial, um, I  
49 guess him loo- looking back at you and the facial expressions and - and - and  
50 so forth?

52 A: Yeah, any...

53  
54 Q: Is - is that what...

55  
56 A: Uh, any - to simplify it, you can tell when someone's looking at you even with  
57 sunglasses on. Uh, and - and that's - I - I was - I was trying to explain that -  
58 that moment. But, uh, yeah, we didn't - I didn't see the whites of his eyes,  
59 obviously. And he didn't see the whites of my eyes 'cause I had sunglasses  
60 on. So it was just a moment. It was a very deliberate look. Um, it was  
61 directly back at me. Uh, and there was no mistaking it. Um, and I don't - I  
62 don't know how to better describe that to you other than, I mean, it was just,  
63 you know when someone's lookin' at you. And you know facial expressions  
64 just 'cause of what we do. And we - we learn to read those things. And it was  
65 a very committed facial expression. And it was a very deliberate look back  
66 over his left shoulder 'cause he had to turn his shoulders to do that. Um, and -  
67 and it - again, in looking back at that - that one part of the incident, I mean, it -  
68 it's pretty clear to me that, you know, that was a look back to see where I was  
69 at. We'll never know what his intentions were. But it was pretty clear to me  
70 at that time that this was gonna - was gonna go bad. Um, and, uh, you know,  
71 obviously, he was armed with a handgun. So, um, you know, in my opinion,  
72 uh, it's pretty clear that he was looking back to see where I was at. And that  
73 could a been the, uh, when he was gonna grab his gun and turn on me or - or,  
74 uh, by - over his shoulder or whatever the case may be.

75  
76 Q: Which goes to, um, I guess your - your s- your state of mind during that time.  
77 Your belief, when he looked back over, is the same as it was the day that we  
78 interviewed you, that you felt that your life was in danger or you - or, uh,  
79 Sergeant McCoy's, uh, life was in danger?

80  
81 A: Yeah, there was no doubt in my mind. I mean, it was, uh, uh, again, it was a  
82 very definite look in his face. It was a very committed look in his face. And,  
83 um, and - and there was just no doubt. And it was that movement, coupled  
84 with the movement of his hands to his waist that - that I knew this was gonna  
85 go to where it went.

86  
87 Q: Okay and that's what you - what you had told us on Saturday, that is the  
88 committed look and s- and so forth. So that - that didn't change at all either?

89

90 A: Yeah, just, again, just wanted to clarify the sunglass thing. Uh, you know, it  
91 might not be a big deal. But it, you know, it kinda bothered me. And that's  
92 why I - I called ya on - on Monday just to make sure that we're clear that, you  
93 know, he didn't take his sunglasses off and look at me and then put 'em back  
94 on. It, you know, it was sunglasses were on the entire time. But there was a  
95 definite exchange in - in a - in a - in a look, a glance, a glare or whatever you  
96 wanna call it.

98 Q: All right, um, do you need anything (Dave)?

99  
100 Q1: No, no.

101  
102 Q: Um, that'll conclude at, uh, approximately 1140 hours.
