Evidence Technician Susan Lane (Supplemental report)

Details:

On 02-18-2012 I monitored and assisted Evidence Technician Susan Lane as she charted the duty weapon belonging to Sergeant Ron Whitt. The procedure was completed at the Magnolia Street Police Station. The duty weapon assigned to Sergeant Whitt was taken as evidence by Evidence Technician Susan Lane. Sergeant Dan Russell provided Sergeant Whitt with a replacement weapon. The following is a synopsis of the charting results. For full details of the charting process and photographs, see the evidence report written by Susan Lane.

Evidence Technician Susan Lane took photographs of Sergeant Whitt as he was dressed during the officer involved shooting. Sergeant Whitt was wearing his department issued M.E.T.R.O. uniform which consisted of a black police vest, cloth badge and police shoulder patches. Sergeant Whitt was wearing black B.D.U. pants and nylon duty belt with a black handgun leg holster. Sergeant Whitt did not appear to have any visible physical injuries or damage to his uniform. Evidence Technician Susan Lane also photographed Sergeant Whitt's handgun and magazines.

Sergeant Ron Whitt:

Duty weapon: Springfield- model 1911 Operator

Caliber: .45 Cal

Magazines: Total of (5), each with a 7 round capacity

Inventory: (1) magazine with (3) live rounds was loaded inside of Sergeant Whitt's duty weapon. (1) live round was in the chamber of the handgun.

(4) additional magazines at full capacity of (7) rounds each was taken from Sergeant Whitt's duty belt. These magazine where photographed and returned to Sergeant Whitt.

Results: Sergeant Whitt's duty weapon was (4) rounds short of full capacity
