W1 Paschal's Vehicle:
Chevy Malibu LP: 6WQT723

Narrative:

On 02-25-13, at approximately 2049 hours, partner Officer Camp and I responded to assist several officers attempting to apprehend a vehicle theft suspect. The suspect had fled from the officers within the complex and as we responding to help, Officer's advised shots had been fired, the suspect was down, and medical aid was needed. When we arrived on scene, I saw a male subject laying near the driver door of a light colored Honda, which was parked facing west. The Honda appeared to have been involved in a collision with a Police vehicle which was parked facing a south/east direction. AMR was on scene rendering medical aid to the subject who was laying next to the Honda. He was then transported by AMR. I was instructed to contact two subjects sitting in a parked vehicle, W1 Paschal and W2 Negrn. The two were parked approximately 20 yards away from where the incident had occurred. W1 Paschal told me the following:

W1 Paschal told me she and her sister, W2 Negrn, had just gone to the store and pulled into the Pepper Tree Apartment Complex, where they live. W2 Paschal told me she drove to the west side gate entrance where an Officer was standing. The Officer told her she needed to back up and enter the complex through the other gate on the east side. W1 Paschal backed her car up and as she was backing, she saw the suspect vehicle within the complex backing up towards the entrance gate. W1 Paschal pointed at the Honda when she mentioned the vehicle that was backing up towards the gate. W1 Paschal told me the vehicle was driving crazy and trying to get out of the complex. W1 Paschal told me her vehicle windows were rolled down and she heard an Officer yell "stop". W1 Paschal told me she continued backing and parked her vehicle in a handicap parking space to the front of the complex. W1 Paschal then saw the Honda ram into the back of an SUV that was parked in front of another smaller vehicle. The SUV then struck the smaller sedan that was parked in front of it. W1 Paschal told me she did not see what happened next but heard several gun shots. I spoke with W2 Negrn who was sitting in the right front passenger seat of her sister's vehicle during the incident. W2 Negrn told me the following:

W2 Negrn told me her sister tried to enter there complex through the west gate but an Officer told them they would need to enter through another gate. Her sister put the car in reverse and started to back up. W2 Negrn saw a Honda backing up towards the front gate. They parked in the handicap parking space and she heard an Officer yell "stop" and "get on the ground". She told me the Honda was backing up pretty fast and he crashed into an SUV parked outside the gate. W2 Negrn told me she rolled up the windows and locked the doors because she was scared. W2 Negrn told me she heard 3 or 4 gunshots but did not see the shooting occur.

I transported the two witnesses to Magnolia Station where I met Officer Braun. Officer Braun stayed with several witnesses at Magnolia Station and I drove back to the scene. Officer Camp and I monitored the crowd at the scene until we were relieved at approximately 2345 hours. No further information.
