NARRATIVE

On 03-01-12 at approximately 0310 hours I was called by Sergeant Russell and told to respond to an Officer Involved Shooting (OIS) in the area of Lincoln and Anna in Riverside. I arrived at approximately 0420 hours and saw that the area was secured with yellow crime scene tape.

I attended a briefing and then was assigned to interview [REDACTED]
[REDACTED] I contacted W-Dales at that address.

W-Dales' Statement

W-Dales told me that he was home alone when the incident occurred. He doesn't sleep very well and he was awake sitting on his living room sofa when he heard what sounded like two gunshots in quick succession outside of his house in the area of Anna Street. He then heard a male voice yelling, "Don't move, don't move", and another voice answering, "You shot me, you son of a bitch you shot me". The original voice then said something he couldn't make out, but it ended with "my partner.....don't move".

W-Dales said he got up off the couch and looked out a south-west facing window where he thought the voices were coming from. This window looks out towards Anna Street and the west wall of his backyard. W-Dales said he could see a uniformed police officer outside the west wall of his backyard. The officer was looking over the wall into his backyard and he had his arm over the wall pointing his pistol at something in his backyard. W-Dales moved and looked out the sliding glass door to his back yard and he saw the suspect lying on the ground near a small planter on the east side of the yard (the yard is only approximately 30 feet by 30 feet). After a minute or two a uniformed officer (Sgt Lambert) knocked on the sliding glass door and asked W-Dales what the address to his house was. After W-Dales told him the address the officer told him to stay inside and someone would contact him soon.

W-Dales said the two shots he heard sounded like they came from the same gun.
