Narrative of Supplemental Report:

On 03/01/12 at approximately 1100 hours, I was notified by Supervising Forensic Technician C. Fuller to attend the autopsy of S/ DUNBAR, Brandon James DOB [REDACTED] on Friday 03/02/12 at 0900 hours.

On 03/02/12 at approximately 0850 hours, I arrived at the Riverside County Coroner-Morgue and met with Detective J. Brandt. I began taking my photographs at approximately 0912 hours (see attached Photo Log). I then received evidence items A01 through A03 from Forensic Technician J. Frisby N4450 at approximately 1045 hours (see attached Property Report for full item descriptions). I finished my assignment and left the location at approximately 1050 hours. I returned to the Magnolia Station at approximately 1150 hours and processed all evidence items. I finished my assignment and placed evidence item A01 into the Magnolia Station Bio-Hazard Locker #7 at approximately 1224 hours. I then placed evidence item A02 into the Magnolia Station Refrigerated Locker #59 and evidence item A03 into the Magnolia Station Evidence Locker #43 at approximately 1225 hours. I then downloaded (120) digital photographs into a secure file format.

No further action was taken.
