On 12-31-13, at about 1133 hours, I was at the Lincoln Station when I heard a "shots fired, 11-11" call broadcast over the radio at Arlington Park. I responded code 3 to the scene. When I arrived I took up a perimeter position on the corner of Hayes and Van Buren. While standing there, I saw W-Carranto sitting on a park bench on the N/E corner of the park. He was facing towards the scene of the shooting. I activated my audio recorder and asked him if he saw what happened. He told me that he was sitting there eating his lunch when he saw two officers talking to two people on a bench. W-Carranto said that he was not looking when he heard the gunshots. He looked up then and saw one officer pointing his gun at the subject who fell over. He said that the second subject was apprehended by the police at the scene also. W-Carranto said that he did not see what caused the shooting. He also could not hear anything being said.																
I measured with my LIDAR unit and his position was about 270' from the suspect. W-Carranto told me that
