Narrative of Supplemental Report:

On January 17, 2009, at about 1756 hours, I responded to 3468 Spruce Street reference a subject with a gun call. The subject was identified by the reporting party as S/Hyatt. [REDACTED]

The reporting party stated S/Hyatt was armed with a hand gun and pointed it at her.

A perimeter was established and the area was cleared with the assistance of San Bernardino Sheriff's Department helicopter, 40 King, and their forward looking infrared (FLIR). We received information S/Hyatt may have fled to 3824 Spruce Street. Officer's Disla, Berretta, Miller, Russell and I responded to the location but were unable to locate S/Hyatt.

All personnel cleared the scene at 1850 hours with S/Hyatt still outstanding.

At about 1937 hours, Officers again responded to the area regarding S/Hyatt. Officers Quinn and Russell located S/Hyatt walking southbound on Mulberry from Holding Street. At some point S/Hyatt produced a handgun, for complete details see supplemental statements by officers Quinn and Russell. Eventually, Officer Taylor arrived on scene and an officer involved shooting occurred resulting in the death of S/Hyatt, for complete details see supplemental statement by Officer Taylor.
