Narrative of Supplemental Report On 1-17-09 at about 1945 hours I received a call from Lieutenant Chuck Griffiths notifying me of a shooting involving an on duty officer at Mulberry Street north of First Street. He advised me the suspect had just been pronounce dead by paramedics from the fire department. He advised of no injuries to the officers involved in the incident and gave me a brief account of what had happened prior to the shooting. I notified Lieutenant Bob Meiers who told be he would notify Captain Boyer. I called on-call Homicide Detectives Rick Wheeler and Rick Cobb and Identification Technicians Sue Lane and Carlton Fuller. I also notified Sergeant Mark Rossi who said he would call additional personnel to the scene.										Reporting Officer G. Masson	
I responded to the scene and met with Detectives Wheeler and Cobb. They requested additional personnel and I called Detectives Troy Banks, Mike Turner, Mike O'Boyle to respond to the scene. interviews of the witnesses at the Magnolia Street station. I assigned Detectives Banks, Turner, and O'Boyle to respond to 3468 Spruce Street the home of the suspect's wife. They were instructed to interview anyone who had observed or had contact with the suspect prior to the incident.

I supervised the crime scene as Detective Dave Smith and the Identification Technicians processed the entire scene. The three detective returned from 3468 Spruce Street and advised me they had interviewed the wife and a young female subject. An older daughter was not home and was not answering her phone and would need to be interviewed at a later time. I released the three detectives and responded to Magnolia Street station. I contacted Lieutenant Blevins who advised me I was finished with my assignment and that Sergeant Rossi would handle the rest of the investigation.
