62. Narrative of Supplemental Report

On 09-13-13, at approximately 2121 hours, I responded to the area of 10<sup>th</sup> Street and Sedgwick regarding an officer involved shooting which had just occurred. I arrived and contacted Sgt. G. Toussaint. I then assisted with the transportation of involved officers to the Magnolia Police Station.

I was told Officer P. Stucker was transporting Officer K. Kauk and Officer V. DeLaTorre was transporting Officer T. Childers. I transported Officer N. Larken and Officer Outlaw in my unit. We left the scene at approximately 2146 hours and arrived at the Magnolia station at approximately 2158 hours. Upon arriving at the station all officers that were directly involved in the shooting were lead to different rooms. At least one other officer stood by with each officer during the entire time. Officers who were identified as witnesses also responded to the station. They were directed to a room where I and other non-involved officers stood by with them. I continued to supervise all of the officers until relieved by Detectives and Supervisors from the Robbery/ Homicide Unit.
