Source and assignment:

I am a Riverside Police Department Detective and I am currently assigned to the Gang Intelligence Unit.

On 09-13-13 at approximately 2120 hours I was monitoring the police radio when an officer involved shooting occurred. Shortly thereafter, Sgt. Smith directed me to respond to the command post at Sedgwick Ave and 10th Street.

At about 2150 hours, I arrived onscene and contacted Sgt. Toussaint and Sgt. Greenstein. They directed me to contact several relatives of the decedent in order to obtain their identifying information, determine if they were witnesses to the incident, and brief statements if possible.

At about 2208 hours I contacted W/Sigala and obtained the following statement (summarized):

W/Sigala's statement:

W/Sigala said that the subject who was shot by the police officers is his father-in law and his wife (the decedent's daughter) is named Thalia. Thalia and their son [REDACTED] have been staying here with his in-laws for the past few days. W/Sigala was at home on Bermuda Ave when he got a call from Thalia saying that he needed to come pick up [REDACTED] because Thalia's father was drunk already and she didn't want him acting up in front of their son. She made some comment about not wanting her son there with her father. W/Sigala said it is fairly common and normal for his father-in-law to be drunk and that he "talks out of his mind". He also said that his father-in-law has been depressed and under a lot of stress recently. His in-laws were being evicted from their house and had nowhere to go but had to be out by Thursday, so they were trying to figure out where they would live. When he arrived at the scene, he parked on 10th Street east of Sedgwick Ave directly across the street from the side yard area of his in-laws' house where the shooting occurred. He was worried about his son because he thought his son was in the yard area where his father-in-law was and that the officers were going to shoot in the direction of his son. He was told to stay back and couldn't see what happened because it was too dark. He didn't personally see it, but he has heard that his father-in-law had a knife and was possibly hurting himself with it. He thinks that the officers shot his father-in-law after he got up.

At about 2218 hours I contacted W/Robles and obtained the following statement (summarized):

W/Robles' statement:

W/Robles said that Maria is her mother and the decedent is her step-father, whose name is Hector Jimenez. She said she was not present when the incident happened. She found out about it when her sister called her crying and told her that the cops just shot her dad.

Both statements were recorded using my department issued digital audio recorder. The recordings were later downloaded into the PUMA audio database.
