1 **W1/RAMIREZ, VANESSA'S STATEMENT CONTINUED**

2 W1/Vanessa stated the residents of that address were standing south of the officers, near the house, and appeared concerned.

4 W1/Vanessa stated she did not hear or see anything else. She also stated she and W2/Ariel were the only two people at her
5 residence at the time of the incident.

7 **W2/RAMIREZ, ARIEL'S STATEMENT**

8 W2/Ariel stated he was inside his residence with W1/Vanessa when he heard approximately one hundred shots or fireworks; he
9 stated there were too many to count. He exited his residence and observed three officers standing in the rear yard of 10745
10 Cypress, near the pink shed; all three officers were holding handguns. The residents of that address were standing south of the
11 officers, near the main house, and were screaming.

13 W2/Ariel stated he did not see or hear anything else. He also stated he and W2/Vanessa were the only people at their residence
14 at the time of the incidence.

17 After collecting the above statements, I maintained an inner perimeter position of the scene on the one/four corner of the
18 residence until I was relieved by Sgt. Banks.
