**Initial response**

On 2/23/15, I received a phone call at home regarding an Officer Involved Shooting that occurred at 2865 Prospect Avenue in Riverside. I responded to the scene and was assigned as Case Agent to investigate.

I learned that S-Lewis had shot at the three victim officers in the backyard of his residence. The officers returned fire at Lewis. Lewis then ran to 2786 Pleasant Street where he committed suicide.
