1 All statements were recorded with my department issued Puma Recorder.

2
3 **Background:**

4 The following witness statements all refer to the suspect as "Steve." Each witness I interviewed stated
5 they did not know "Steve's" last name or address. They said he lives around the corner and his son plays
6 baseball with one of their family members.

7
8 **Statement: W1/Talia**

9 W1/Talia reported on 02/23/15, she was at her residence located at 2786 Pleasant Ave. She said she heard
10 four gunshots from outside. W1/Talia said a guy her family knows, "Steve," ran into the house through
11 the garage door and ran into her dad's room. W1/Talia said she heard what sounded like "Steve" racking a
12 gun. W1/Talia got her younger family members Yazmine and W2/ [REDACTED] and ran into their Aunt Lora's
13 room. W1/Talia and other family members hid in Aunt Lora's closet. When W1/Talia's dad James came
14 into her Aunt Lora's room, he told W1/Talia to call police. W1/Talia said she then heard one shot and the
15 family ran outside to get the police.

16
17 **Statement: W2/Camren**

18 W2/ [REDACTED] reported on 02/23/15, he was asleep in his dad's room (James Dottery [REDACTED]).
19 W2/ [REDACTED] said he was woken by "Steve" talking in the room. W2/ [REDACTED] said "Steve" was acting
20 weird, jumping around and holding his butt area. W2/ [REDACTED] said "Steve" had a shotgun. W2/ [REDACTED]
21 then heard "Steve" say "they got me." W2/ [REDACTED] said his sister, W1/Talia came into their dad's room
22 and grabbed him to get him out of the room. They went and hid in their aunt Lora's room. W2/ [REDACTED]
23 said he then heard one shot and the family ran outside.

24
25 **Statement: W3/Deandre**

26 W3/Deandre reported on 02/23/15 he was in his room (he shares a room with his mother Lora) at his
27 residence located at [REDACTED]. He said he heard five to six gunshots. W3/Deandre said after that
28 he heard someone in his uncle's room. He then heard a gun go off inside the house. W3/Deandre said he
29 and other family members ran outside of the house. He never saw the suspect.

30
31 **Statement: W4/James Dottery [REDACTED]**

32 W4/James reported on 02/23/15 he was in his bedroom at his residence located at [REDACTED]. He
33 was getting ready for bed when several family members came into his room. He stayed inside until he was
34 told to come outside by police. W4/James never saw the suspect and never heard any gunshots.

35
36 **Statement: W5/Renee**

37 W5/Renee reported on 02/23/15 she was inside the den area of her residence located at [REDACTED]
38 [REDACTED] watching television with her daughters and her son. W5/Renee said a family friend named "Steve"
39 came into the house through the garage door. "Steve" was acting strange and was limping. W5/Renee said
40 "Steve" went to the back of the residence towards the bedrooms. W5/Renee said she thought something
41 was going on, the kids were moving in the back bedroom. W5/Renee then heard a gunshot and she and
42 other family members ran out of the front door.

Statement: W6/James Dottery DOB [REDACTED]

W6/James reported on 02/23/15 he was in the den area of his residence located at [REDACTED] A family friend named "Steve" came into the house from the garage door and went to the back of the residence. W6/James said his brother Dejon said "Steve" had a gun. W6/James and other family members went into their grandfather's room. W6/James said he heard one gunshot and then his aunt told him to get the police.

Statement: W7/Dejon

W7/Dejon reported on 02/23/15 he was in the den area of his residence located at [REDACTED] sleeping. W7/Dejon said he suddenly heard his sisters yelling. W7/Dejon said he went to his dad's room (James Dottery [REDACTED] and saw "Steve" with a shotgun pointed at the ground. He was talking to W7/Dejon's dad but W7/Dejon ran to his Aunt Lora's room when he saw the shotgun and didn't hear what "Steve" was saying. Once in his aunt's bedroom, W7/Dejon said he heard a "boom" and the whole family ran outside to call police.

After gathering the above listed statements, Officer Contreras and I remained at the scene for scene security on the perimeter at Pleasant and Forest.
