DETAILS:

I am currently assigned to the Post-Release Accountability and Compliance Team (PACT), which consists of Officers and Deputies from multiple agencies throughout Riverside County. One of our duties is to conduct compliance checks of persons who are currently on Parole, Probation, Mandatory Supervision, Supervised Release and Post Release Community Supervision (PRCS).

On Tuesday, November 18, 2014, about 1349 hours, Detective Detmer of the Riverside Police Department Narcotics Unit, came into the PACT office and requested assistance from the team and asked us to conduct a Wall-Stop of an individual that his Unit was investigating reference narcotics sales. Detective Williams obtained all of the suspect information from Detective Detmer and asked the rest of the team to meet in the parking lot of the Riverside Police Department Magnolia Station.

Once at the brief, Detective Williams assigned Deputy Stanley and I to be a containment / Emergency Response Unit. Based on the information provided from Detective Detmer, (SUS) Vincente Martinez was armed with a handgun. Deputy Stanley and I drove to the corner of Tyler Street and Keller Avenue. We parked our vehicle in the southwest corner of the parking lot of La Granada Elementary School.

While at the location we heard Officer Adcox attempt to conduct a traffic stop of (SUS) Martinez' vehicle. The vehicle failed to stop and Officer Adcox continued following the vehicle. We drove to the location of the last known location put out by Officer Adcox which was Bushnell Avenue and Campbell Avenue. As we arrived at the area I heard Officer Arangure transmit, "Shots fired, Shots fired." Officer Arangure stated the location was 433 Bushnell Avenue. We responded to the location pulling our vehicle just short of the driveway to the residence.

We retrieved "Police Tape" from the trunk of our vehicle to immediately secure a crime scene at the front of the residence to preserve any evidence. After securing the front of the residence, Deputy Stanley and I walked to the rear of 3541 Bushnell where Corporal Marquez asked us to relieve Officer Ortiz, who was standing in the back yard of 10479 Keller Avenue. We climbed the fence and relieved Officer Ortiz.

Deputy Stanley assigned me to obtain all of the Fire Department personnel's contact information. After the Riverside Fire Department finished with Martinez, we were asked to leave the scene. I notified Riverside County Probation Department Supervisor Wesley Brumbaugh and advised him of the situation and my involvement. I took no further action in this case.
