DETAILS:

On 112111, at 1925 hours, I was dispatched to [REDACTED] in the unincorporated area of [REDACTED]. This was in reference to a theft of firearms. I contacted the reporting party/victim, Zachary Gilbert via the telephone and he told me the following information.

He discovered four of his weapons missing this weekend on a camping trip. He kept the guns locked up in his 2005, Forrest River fifth wheel trailer. The guns had been in there since May, 2011, however, he had not used the trailer since then and did not realize they were gone. He travels to Canada for business and is gone for long periods of time.

He informed me, that he believes his stepson, Braden Tone took the guns without his permission. He explained that there was a spare key that Braden had access too, and there was no forced entry into the trailer. He further added that, he confronted Braden about the guns yesterday, and Braden admitted to taking the guns only to use for protection at a house in Temecula where he and his friend hangout. Braden told Zachary the unknown house was raided by the Temecula Police and the guns were possibly confiscated.

I did a records check on the guns and located three handguns registered to the victim, Zachary Gilbert; a Sig Sauer, P225, 9mm, serial #M524770, Springfield XD40, semi-auto, serial #US200571, Charles Daly 1911, 45 cal, serial #CD003095. None of the guns were listed as recovered. Zachary told me he was also missing a Colt M4, 22caliber rifle, unknown serial number. He desired prosecution of Braden Tone for the theft of his guns. I gave Zachary the case number, and had three of the four weapons entered into the Clets system by N4500 as stolen.

I attempted to contact Braden via the telephone as his last known address is at 13106 Woodmont Street, Poway, San Diego County. I received no answer and left a voice message for Braden to contact me. I again attempted to contact Braden on 112211, and 112311 and met with negative results.

On 112711, at 1630 hours, I responded to a suspicious persons call at a local park on Central Park Drive and Calistoga, in Murrieta. Upon arrival several male subjects fled on foot. I was able to locate and detain one of the subjects, who I later identified as Braden Tone. Braden appeared to be under the influence of alcohol. His eyes were bloodshot and watery and he smelled of alcohol on his breath and person.

2 I advised Braden that he was being detained for a previous theft of several handguns. Braden
3 stated he had nothing to say about the incident. I explained to him, based on the information from
4 the victim, I was booking him for felony theft. Braden was booked into the SWDC on the charge
5 of 487 PC.
