Narrative of Supplemental Report:

On 11-22-13, at approximately 2327 hours, I heard Officer Hunt broadcast he was at First Street and Vine Street with shots fired. I responded from University Ave. and Chicago Ave. I arrived on scene and observed Officers taking cover behind a police unit on the West side of the street. A Tan Nissan Altima 4 door was stopped facing north bound at 3020 E. La Cadena Dr.

A Riverside Police unit was facing south bound in the middle of E. La Cadena. (Now known as Officer Hunts vehicle)

I contacted Officer Hunt who was taking cover behind another police unit. I asked him if he was injured in any way and checked his status. He was not injured, and he stated the following: He believes the suspects fired two or three gun shots at him in a west bound direction. He stated he believes he fired back with his department issued hand gun two or three rounds in an east bound direction at the vehicle.

I asked if there were any outstanding suspects and he stated he did not know, the passengers door was open and he was not sure how many suspects were inside the vehicle, or if anyone ran from the vehicle. He thought there was a suspect attempting to hide on the passenger's front seat of the vehicle.

I asked if he had any description of anyone inside the vehicle and he stated one suspect was a Hispanic male wearing a cap and a black jacket.
