1 DETAILS:

2 On 11-22-13 at approximately 2327 hours, I responded to a call of an Officer involved shooting at 3020
3 E. La Cadena Dr. Upon arrival, I established a perimeter position at E. La Cadena Dr. and Malta Pl.
4 Once the suspect was in custody, I responded to the scene.

5
6 I assisted with locating possible witnesses. I contacted [REDACTED] at 3055 E. La Cadena
7 Dr. [REDACTED] stated that she lives at [REDACTED]. She was in the front
8 yard of the residence for a church function when she saw an officer stop his patrol car in front of the
9 house. [REDACTED] said the officer exited the patrol car and approached a vehicle that was parked on the east
10 side of E. La Cadena Dr. As the officer approached, a male (who she could not identify) started shooting
11 at the officer from the passenger side of the vehicle. The officer began to walk backwards to take cover
12 behind the patrol car. Fearing for her safety, [REDACTED] ran into the residence. She did see or hear anything
13 else.

15 There were no other witnesses for me to contact.

17 Sgt. Cash assigned me with securing the perimeter of the crime scene until approximately 0400 hours.
