**Narrative:**

On 11-25-13, at approximately 0900 hours, I responded to the Riverside County Sheriff-Coroner's Office reference an autopsy for S/ Adolfo Ramirez. On 11-22-13, Ramirez was involved in an Officer Involved Shooting at 3020 E. La Cadena Drive in the city and county of Riverside. Ramirez was pronounced deceased at the scene and transported to the Coroner's Office.

The autopsy began at approximately 0910 hours and was performed by Forensic Pathologist Dr. Park. Dr. Park conducted an overall examination for external injuries. Ramirez had several tattoos, which were documented in photographs. Ramirez had an EKG pad on the top of his right hand and two additional pads on his lower back. Ramirez had abrasions on his face, which appear consistent with asphalt. He had additional abrasions to the top of his left hand, left wrist, left forearm, left inner knee, left shin and calf, which appear consistent with the K-9 apprehension. These wounds are not puncture wounds but rather appear to be scrapes. The injuries on the left arm are consistent with tears to his black leather jacket. His left pant legs were not torn but showed marks consistent with bite impressions. There was one bullet wound to his upper left chest just above the nipple.

During the internal examination, it was found the projectile entered Ramirez's left chest and traveled in a downward trajectory and traveled left to right. The projectile struck his heart, diaphragm and liver, and bruised his left lung. The projectile (#BE-07) was recovered by Dr. Park.

Senior Forensic Technician T. Ellis took photographs and collected all the evidence items. Refer to his Supplemental Report for details.

The autopsy concluded at approximately 1055 hours and Dr. Park listed the cause of death as: *Gunshot Wound of Chest.*

Dr. Park's Autopsy Protocol is forthcoming. Refer to her Protocol for additional details.
