On the above date and time, I responded to 3750 Myers St #55 to assist with the supervision of a radio call of a suicidal subject with a gun. Upon arrival, Sergeant's Cash, Lambert and Stump were already to the front of apt. #55 supervising a crew of officers. I was just below the apartment and just out of view when I heard shots being fired. I looked back up and saw a subject being handcuffed. I then went up to the apartment at the request of Sgt. Cash to assist with clearing the apartment for any victims and/or additional suspects. None were located. I then remained at the scene and handled the management of patrol personnel who were assigned to scene security to preserve the scene. I escorted the officers involved in the shooting to the parking lot and away from the suspect. I ensured that the officers did not discuss the incident amongst each other and asked safety questions. I confirmed that all officers involved were not injured and then asked the direction of travel and how many shots were fired by each officer. The following describes what was answered by each officer:

Narrative Cont'd:

Officer Gomez #1666 stated that he shot 3 times toward the subject in the direction of the apartment in question.

Officer Lim #1605 stated that he shot twice directly toward the subject in the direction of the apartment.

Officer Ouk #1615 stated that he shot 1 time in a downward direction toward the subject in the direction of the apartment.

Officer Serrato #1569 stated that he shot twice in the direction of the subject/ apartment in question.

I then requested additional officers to the scene to assign each officer involved an on-duty officer to stand by with. Before they arrived, I was relieved by Sgt. Tipre in order to manage the scene.

I then assisted with the debrief provided to detectives and staff. Once completed, I remained at the scene to manage the patrol personnel at the scene.

I was relieved at 0700 hours and cleared the scene at 0704 hours.
