

**Interview of Witness Ayers**

W-Ayers was interviewed at the Magnolia Station. The interview was digitally recorded and later downloaded to the department server.

Ayers is the sister of V-1 Arabella. She lives in Colorado and is currently visiting her sister and staying at her house.

Ayers said that Arabella and S-Virgil had been together for over ten years, but they broke up. She said Virgil has been living across the street. She said that yesterday, Arabella filed a restraining order against Virgil. Arabella had told her that Virgil had been stalking her.

Ayers said that Arabella and V-2 Malvin had been friends for a while, but she did not know if they were dating.

Ayers said that earlier today, she and Arabella went shopping. She said that Malvin and his friend Marvin were at Arabella's house when they returned from shopping. She said they were going to barbeque.

Ayers said that she was cooking inside the kitchen when she saw Virgil standing at the rear door leading from the kitchen to the backyard. She said Virgil immediately grabbed Arabella who was also in the kitchen, by the hair and drag her outside. She said Virgil had a handgun in his hand. She said that he dragged her by the hair and started shooting downward at her.

Ayers said that her mother tried to help Arabella, but fell to the ground outside. She said she grabbed the phone and immediately ran to the back bedroom where her son was. She said she heard a lot of gunshots. She said it sounded like 25 to 30 shots. She said she grabbed her son and hid in the bathroom. She said she heard gunshots through the house and into the front yard. She said she stayed in the bathroom with her son until police arrived.

Ayers said she did not see any of the shooting after she saw Virgil shoot Arabella when he grabbed her by the hair. She said she heard a lot of screaming, but did not hear specific words from anyone.

Ayers had no further information.
