ORDINANCE NO. 7279

AN ORDINANCE OF THE CITY OF RIVERSIDE, CALIFORNIA,
ESTABLISHING THE LEVEL OF COMPENSATION FOR MEMBERS OF
THE CITY COUNCIL AND PROVIDING CERTAIN FRINGE BENEFITS,
AND REPEALING ORDINANCE NOS. 7199 AND 7277 IN THEIR
ENTIRETY.

The City Council of the City of Riverside, California, does ordain as follows:


Section 1: Effective 30 days after adoption of this ordinance, and beginning with the first pay period thereafter, each member of the City Council shall receive compensation of *Three Thousand Four Hundred Forty Eight Dollars* (\$3,448.00) per month. The member serving as Mayor Pro Tem shall receive an additional sum of *One Hundred Five Dollars* (\$105.00) per month during such period of service. Said compensation shall be payable at the same time and manner as compensation of other officers and employees of the City.

Section 2: Each member of the City Council shall receive those fringe benefits as are currently available to and have been established for the City Executive Management employees with the exception of sick leave and vacation accruals pursuant to the City's Fringe Benefits Resolution.

Section 3: Ordinance Nos. 7199 and 7277 are hereby repealed.

Section 4: The City Clerk shall certify to the adoption of this ordinance and cause publication once in a newspaper of general circulation in accordance with Section 414 of the Charter of the City of Riverside. This ordinance shall become effective on the 30th day after the date of its adoption.
