QUESTIONS REGARDING THE MAIN MUSEUM DURING THE TEMPORARY CLOSURE

Question #1	Why is the Riverside Metropolitan Museum closed?
Answer	The Riverside Metropolitan Museum is temporarily closed to prepare for and plan renovation and expansion. Relocating collections that are onsite is, by itself, a massive undertaking. Other institutional changes under way include restructuring staff, revising policies and procedures, planning re-opening exhibitions, addressing large-scale collection documentation and storage projects, and focusing on Harada House. Question #2	Who authorized the closure of the Main Museum?
Answer	The closure of the Main Museum was approved by the Riverside City Council on July 11, 2017, so that staff could focus on a long list of special projects that
	cannot be accomplished simultaneously with normal operations.

Question #3	How long is the closure period?
Answer	The closure period was announced to last three years, beginning September 5,
	2017. However, the intention is to approach this rare opportunity to reinvent
	the museum with our highest priority being an exceptional result. It is likely
	that the closure may last about four years or so.

Question 4	What Museum programs and services will continue during the closure period?
Answer	 Heritage House will remain open, offering some additional small exhibitions and programs: http://www.riversideca.gov/museum/heritagehouse/
	 Annual Insect Fair will continue. The museum will also maintain a presence at selected citywide festivals and events.
	 Small neighborhood exhibitions will be prepared, accompanied by special programming.
	 Education partnerships and school outreach will continue on a limited basis, and the museum will continue to participate in such events as First Sundays.
	 Monthly Metropolitan Museum Board Meetings will continue. The meetings are open to the public. See calendar for dates and agendas: https://riversideca.legistar.com/Calendar.aspx
	Special public programs and events will be announced from time to time.

	4. Detailed planning of the renovated and expanded downtown site. As
	of February 2019, Pfeiffer Partners Architects has been chosen to be
	the project architect.
