## 7. IMPLEMENTATION

### Implementation Tools Overview for the University Neighborhood Plan

Rather than being a document that sits on a shelf, the University Neighborhood Plan includes action items and assigns accountability. The following Implementation Tool Tables identify responsible agencies, appropriate time frames and interrelationships between the implementation tools and policies. The intent is to increase the effectiveness and efficiency of implementing the University Neighborhood Plan by identifying related tools and policies.

The Tools introduced throughout this document are listed in the following three tables. The first column includes the Tool number as listed in the previous sections; the second column includes a description of the Tool; the third column lists the responsible agencies with the lead agency in bold typeface; the fourth column includes a proposed timeframe for the commencement of the Tools or identifies a tool as ongoing; and the fifth column indicates the related Policy that can be found within the preceding sections of this document.
