



City of Riverside Department of Public Works, Animal Services Application for Residential Kennel/Cattery Permit

1. INSTRUCTIONS

1. Complete **Part 2 – Applicant Information**. Please print legibly.
2. Complete **Part 3 – Animal Information**. List all animals kept or cared for at the property. All dogs, over the age of 4 months, must have a valid City of Riverside Dog License at the time of the application and submit proof of license when the application is submitted. Alternatively, dog licenses can be purchased at the same time a kennel/cattery permit application is submitted if all license documentation is provided. All cats over the age of 4 months must be microchipped (numbers must be provided), and if over the age of 7 months must be spayed or neutered.
3. Complete **Part 4 – Property Owner Acknowledgment**. If the applicant rents or leases the property, the property owner must complete Part 4. Original signatures are required (faxes, emails, copies, etc. will not be accepted).
4. Complete **Part 5 – Caretaker Acknowledgment**. If the applicant has another individual caring for the animals, the caretaker must complete Part 5.
5. **Part 6 – Applicant Acknowledgment**. Read the declaration prior to signing and dating the application.
6. Submit both pages of the application, copies of dog licenses, and a **\$121** (residential or **\$541** (commercial) application fee* to:
