### Preferential Parking Zone (PPZ) Permit Acknowledgement

- Resident PPZ permits are issued to a designated vehicle and are non-transferable between vehicles. They are issued to residents who have provided proof of residency, including a current State of California vehicle registration showing residency within a PPZ located in the City of Riverside.
- All Residential PPZ permits will be online "virtual permits" starting July 1, 2024. The physical decal PPZ permits have been discontinued and will not be available or mailed out. License plates will be utilized instead to validate Residential PPZ permits. For residents that want to print and display a paper PPZ permit on their dashboard, an online option has been made available; however, this is not a requirement.
- All Guest PPZ permits are being issued in the form of hangtags to be displayed on the rear-view mirror of all guest vehicles. Guest PPZ permits shall be used solely for guests visiting the resident. Please be sure to collect your Guest PPZ permits before your guests leave your home. Lost or stolen Guest PPZ permits are subject to a replacement fee.
- Use of a Residential or Guest PPZ permits signifies the designated vehicle is not subject to the posted PPZ restrictions. All other parking regulations continue to apply. For example, the Riverside Municipal Code prohibits: storage of vehicles on the street for more than 72 consecutive hours or parking on the street during street sweeping hours.
- The Residential or Guest PPZ permits does not provide a reservation of any parking spaces.
- Permits are valid for a three year period ending on June 30, 2027.
