I, Robert S. Kipper, certify that I am a Registered Civil Engineer of the State of California;

That a survey was prepared under my supervision and direction in Tract 9565. That said Tract was filed June 21, 1979 in Map Book 105, pages 30 through 33 inclusive, in the office of the Recorder of Riverside County, California;

That the following data shown on said Tract Map is omitted and is corrected as follows:

- 1. Lot A (Via Zapata, a private street) is a strip of land bounded Southerly by the tract boundary of Tract 9565; bounded Northerly by the Southerly line of Lots 1 through 15 and the Southwesterly line of Lots 16 through 26, the Southerly line of Lot 1 being extended Westerly to its intersection with the centerline of La Paloma (private street) and the Southerly line of Lot 9 being extended Easterly to meet the Southerly line of Lot 10; bounded on the West by the centerline of La Paloma (private street); and bounded on the Southeast by the Southeasterly line of Lot "C" of Tract 3802 as shown on Map on file in Map Book 60 at pages 14 and 15, Records of Riverside County, California and the Northeasterly extension of said Southeasterly line to its intersection with said Southwesterly line of Lot 26.
- 2. Lot "B" (Via Zapata, a private street) is a strip of land 44.50 feet wide lying adjacent to and Northerly of the Southerly tract boundary of Tract 9565 and being bounded on the West by Canyon Crest Drive and bounded on the East by the centerline of La Paloma (private street).
