

D. Parcel 2 of Parcel Map 23026 was subsequently acquired by SPECTRUM ASSOCIATES NO. I, a California general partnership ("Spectrum"). Spectrum thereafter included Parcel 2 of Parcel Map 23026 in the approximately 136 acres of unimproved real property subdivided by Parcel Map 24536. As a condition to the approval of Parcel Map 24536, Spectrum was required to execute and record a covenant and agreement acknowledging the imposition of certain requirements related to the use and development of the property, including requirements regarding certain off-site improvements and street rights-of-way, and agreeing that no parcel would be developed without improved public access to that parcel.

E. As Parcel Map 24536 is restricted by the Covenant, Agreement and Declaration of Restrictions executed by Spectrum on December 21, 1989 and recorded February 8, 1990, as Instrument No. 050529, Official Records of Riverside County, California, as said Covenant has been amended from time to time, Spectrum has requested that the Covenant and Agreement executed by the Goldschmidts be removed as to that part of Parcel Map 23026 now included as a part of Parcel Map 24536.

F. Paragraph 3 of the Covenant and Agreement executed by the Goldschmidts on December 16, 1987, provides in Paragraph 3 thereof that it shall continue in effect until such time as it has been released by the City Council of the City of Riverside.

G. By action duly taken on April 5, 1994, the City Council of the City of Riverside authorized the release from Parcel 2 of Parcel Map 23026 of the Covenant and Agreement executed by the Goldschmidts on December 16, 1987 and authorized the City Manager of the City of Riverside or his authorized designee to execute the Partial Release of Covenant and Agreement.

NOW, THEREFORE, incorporating the above recitals, the City Council of the City of Riverside hereby releases the following described real property from the Covenant and Agreement executed by HELEN M. GOLDSCHMIDT, Executor of the Will of PAUL GOLDSCHMIDT, deceased, LUCILE GOLDSCHMIDT, and LUCILE GOLDSCHMIDT and ADLAI F. GOLDSCHMIDT, in trust, on the 16th day of December, 1987 and recorded December 18, 1987 as Instrument Number 357272, Official Records of Riverside County, California, and said Covenant and Agreement shall be of no force and effect as to the following described real property as of the date of this Partial Release of Covenant and Agreement:

Parcel 2 of Parcel Map 23026 as shown by map on file in Book 147 of Parcel Maps, at pages 69 and 70 thereof, records of Riverside County, California.
