COVENANT AND AGREEMENT AND
DECLARATION OF RESTRICTIONS

(SINGLE FAMILY DWELLING RESTRICTION)

THIS COVENANT AND AGREEMENT AND DECLARATION OF RESTRICTIONS is made and entered into this // day of May, 1999, by MARY M. MCDONALD, an Unmarried Woman, ("Declarant") with reference to the following facts:

A. Declarant is the fee owner of the following described real property ("the Property") situated in the City of Riverside, County of Riverside, State of California:

LOT 33 OF LINCOLN GROVES UNIT NO. 1 AS SHOWN BY MAP ON FILE IN BOOK 27 PAGES 63 AND 64, OF MAPS, RECORDS OF SAID RIVERSIDE COUNTY.

B. The Property, known as 2906 Kathleen Street, Riverside, California, is located in a Single Family Residential ("R-1-80") Zone and is developed with a single-family residence and covered parking.

C. Declarant wishes to construct an accessory building which will consist of two rooms which will be used as either bedrooms or an office and music room. In each of these rooms there will be sinks. Each room has its own separate door to the outside and a bathroom.

D. As a condition of the granting of a building permit, Declarant is required to record a covenant subject to review and approval of the Planning and Legal Departments prohibiting the accessory structure from being rented or used as more than a single dwelling unit and prohibiting installation of any kitchen facilities in the accessory building.

E. Declarant is willing to record such a covenant so that the single-family residence and the new accessory building will not mistakenly be used as more than one or multiple dwelling units, as one primary dwelling unit and one auxiliary dwelling unit or for commercial or business activity.

NOW, THEREFORE, for the purposes of complying with a condition imposed by the City of Riverside for the granting of building permit, and restricting the use of the Property to single-family residential, Declarant hereby covenants and agrees with the City of Riverside that the following restrictions shall apply to the Property:

1. The single-family house and the accessory building shall be used as one dwelling unit.
2. No kitchen facilities shall be permitted, maintained or installed in the accessory building.
3. Neither the accessory building nor the existing main residence shall be sold, rented or leased separately from the other.
4. Except as otherwise permitted by the provisions of Title 19 of the Riverside Municipal Code, no commercial or business activity shall be conducted on the Property.
5. The on-site covered parking required by Title 19 of the Riverside Municipal Code shall be maintained at all times.
6. The terms of this Covenant and Agreement and Declaration of Restrictions may be enforced by the City of Riverside, its successors and assigns. Should the City of Riverside bring an action to enforce any of the terms of this Covenant and Agreement and Declaration of Restrictions, the prevailing party shall be entitled to court costs, including reasonable attorneys' fees.
7. This Covenant and Agreement and Declaration of Restrictions shall run with the land and each and all of its terms shall be binding upon Declarant, his heirs, successors and assigns, and shall continue in effect until such time as released by the Planning Director of the City of Riverside, California, by a writing duly recorded.

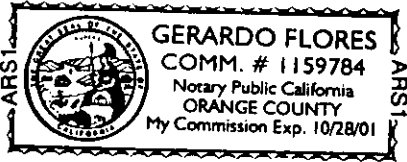
