THIS AGREEMENT made and entered into this 26th day of April 1982, by and between ROBERT B. BLUMENTHAL, hereinafter referred to as the "First Party", and MARY MARCHESE, hereinafter referred to as the "Second Party",

WITNESSETH:

WHEREAS, First Party owns that certain land located in the City of Riverside, County of Riverside, State of California, described as:

That portion of Lot 16 in Block 2 of the Lands of the Riverside Land and Irrigation Company, as shown by map recorded in Book 1 page 70 of Maps, San Bernardino County records; described as follows:

Commencing at the intersection of the Northwesterly line of said Lot, with the Southwesterly line of Jackson Street; thence Southeasterly on said Southwesterly line of Jackson Street, 132 feet to the true point of beginning; thence Southwesterly parallel with the Northwesterly line of said Lot, 150 feet; thence Southeasterly, parallel with the Southwesterly line of Jackson Street, 132 feet; thence Northeasterly parallel with the Northwesterly line of said Lot, 150 feet to the Southwesterly line of Jackson Street; thence Northwesterly on said Southwesterly line of Jackson Street, 132 feet to the true point of beginning.

This portion of Lot 16 in Block 2 as above is also recorded in Records of Survey Book 19 page 48, of Records of Riverside County, California.

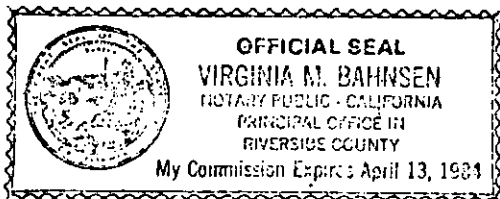

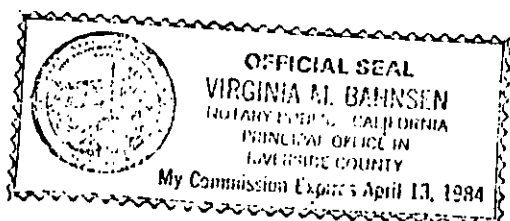
