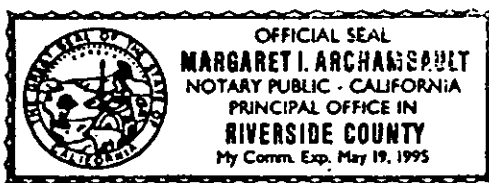

Parcel A

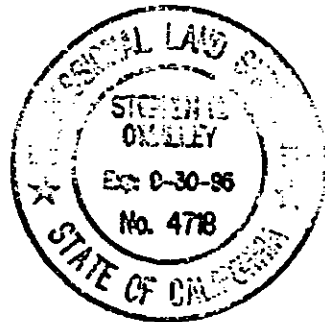

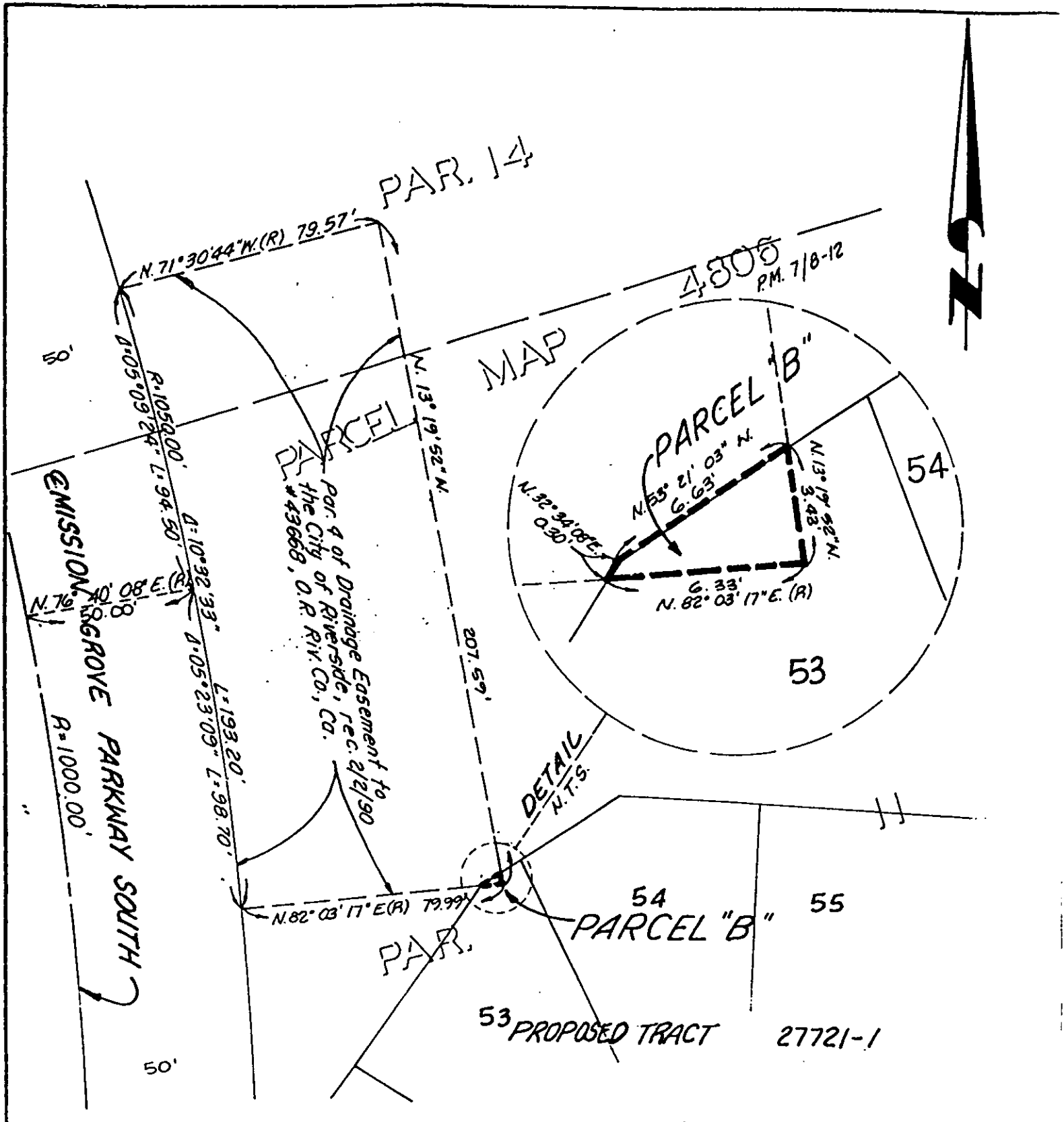
