Acquired by vacation of School Street, Canal Ave. and the right of way of the lower canal of the Riverside Water Company, in and to that certain lot, piece or parcel of land Situate, lying in the City of Riverside, County of Riverside, State of California, and bounded and particularly described as follows:to-wit-

Beginning at a point on the Westerly line of Eliza Street as shown in book 1, Page 61 of Maps, records of Riverside County, California, now called Brockton Avenue, said point being the intersection /2-3-4~ of the Northerly line of lot 29, Block 7, Tibbetts Tract as shown in aforesaid records, produced Easterly, and the Westerly line of Brockton Avenue produced Southerly along the Westerly line of Brockton Avenue.
