That certain easement lying within the real property located in the City of Riverside, Riverside County, California, described as follows:

The easterly one-half of that portion of a certain strip of land 25 feet wide, known as CANAL NO. 1, as conveyed to the Twin Buttes Water Company by deed recorded December 3, 1917, in Book 473, Page 16 of Deeds, and by deed recorded January 2, 1918, in Book 474, Page 187 of Deeds, and by deed recorded August 11, 1919, in Book 508, Page 101, et seq., of Deeds, all records of Riverside County, California, located within Lot 21 of Fractional Section 15, Township 3, South, Range 6 West, as shown by map of the Rancho La Sierra, on file in Book 6, Page 70 of Maps, records of said Riverside County, which lies northerly of the westerly prolongation of the southerly line of Block C of Bonnie Banks Tract, as shown by map on file in Book 11, Page 55 of Maps, records of said Riverside County, and which lies southerly of a line which is parallel with and distant 20.00 feet southerly, as measured at right angles, from the northerly line of Block C.

This description was prepared by me or under my direction in conformance with the requirements of the Land Surveyors Act.

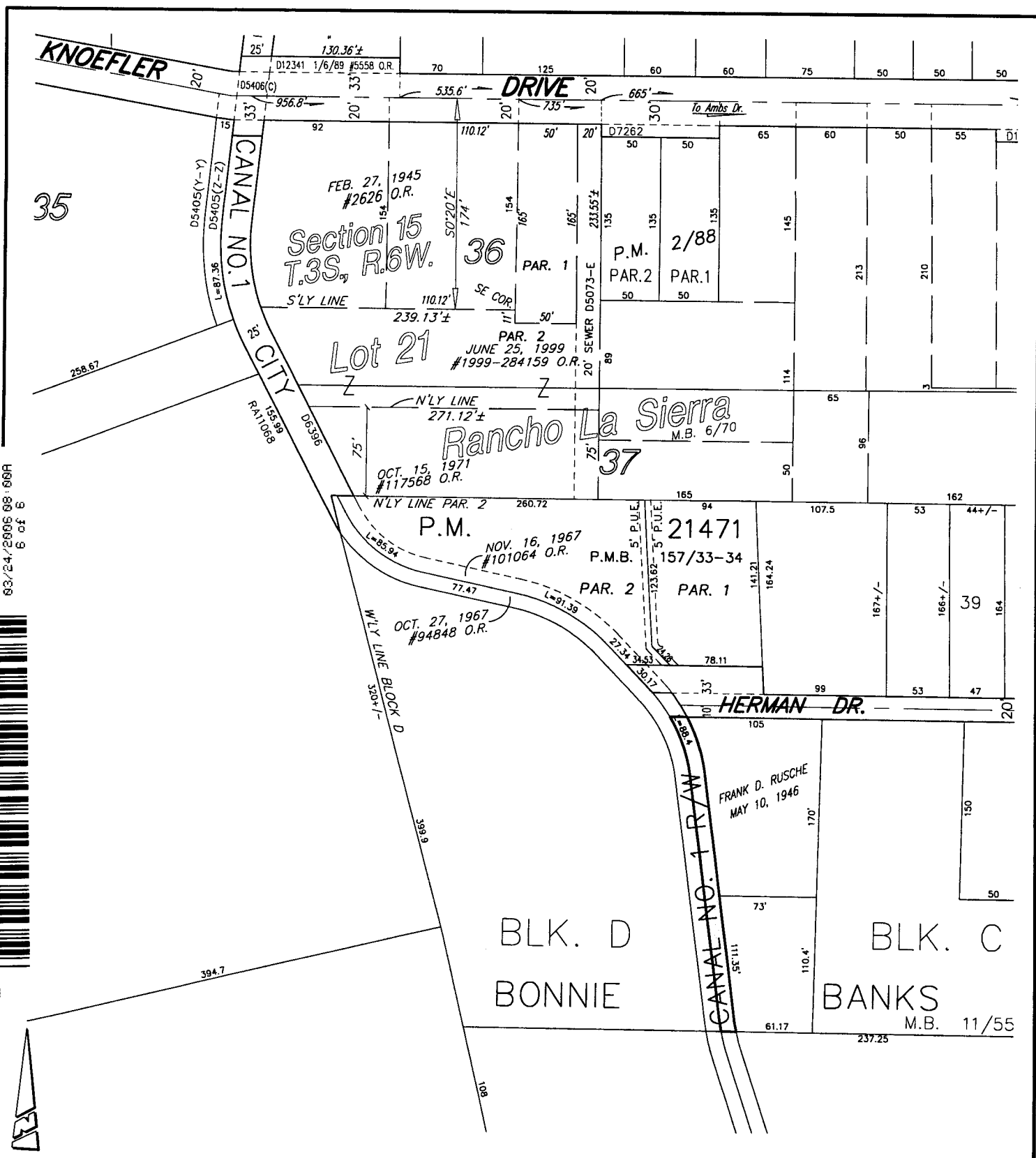
