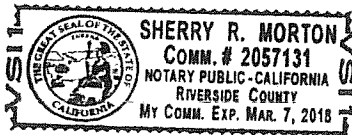

That certain easement located in the City of Riverside, County of Riverside, State of California described as follows:

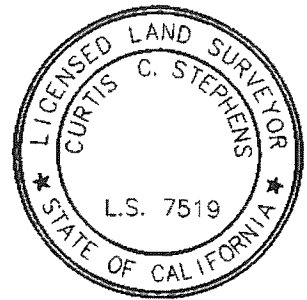
