

RESOLUTION NO. 1545 (NEW SERIES)
 (RESOLUTION DECLARING THAT CLOSING UP AND
 VACATING HAS BEEN COMPLETED)
 (A CERTAIN ALLEY IN MARIVILLA TRACT)

WHEREAS, the common Council of the City of Riverside did on the 23rd. day of April, 1929 pass its Resolution No. 1535 (N.S.) ordering the work of closing up and vacating a certain alley in Marivilla Tract, in said City hereinafter described, as contemplated by resolution of Intention No. 1517 (New Series) and,

WHEREAS, the Superintendent of Streets of said City has reported to said Common Council that the work of closing up and vacating a certain alley in Marivilla Tract has been done and completed,

NOW THEREFORE, be it resolved that the Common Council hereby determines that that certain alley in Marivilla Tract in said City hereinafter described is closed up and vacated.

That certain alley in Marivilla Tract affected by this resolution is particularly described as follows;

Commencing at the point of intersection of the center line of Luther Street with the center of new Magnolia in the City of Riverside, California, thence Westerly along the center line of Luther Street to the intersection of said line with the West Property line of New Magnolia Avenue, produced Southwesterly; thence Northeasterly along the said West Property line of New Magnolia Avenue, produced Southwesterly to the Southeast corner of Lot 6, Marivilla Tract, as recorded in Book 8 of Maps, page 87 Records of Riverside County, California, thence West along the South Property line of said Lot 6, and the North line of Luther Street to the Southwest corner of lot 6, said point being the point of beginning; thence Northerly along the West line of said lot 6, to the Northwest corner thereof and the Southwest corner of lot 5, said Marivilla Tract, thence Northeasterly along the Northwest lines of Lots 5, 4, 3, 2 and 1, said Marivilla Tract to the Northwest corner of said lot 1; thence Westerly on a direct line to the Northeast corner of lot 9, said Marivilla Tract,

thence Southwesterly along the Easterly lines of Lots 9 and 10, said Marivilla Tract to the Southeast corner of said lot 10 and the East line of Lot 7, said Marivilla Tract, thence Southerly along said East line of Lot 7, to the Southeast corner thereof and the North line of Luther Street; thence Easterly along the North line of Luther Street, 16 feet to the Southwest corner of lot 6, said Marivilla Tract and the point of beginning.
