A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, AUTHORIZING THE MAYOR AND CITY CLERK TO EXECUTE A QUITCLAIM DEED TO OSCAR L. HARRIS AND NORA HARRIS.

WHEREAS, the City of Riverside owns the following described property situate in the City of Riverside, County of Riverside, State of California:

Beginning at a point on the Southerly line of 14th Street 47.5 feet Easterly from the Easterly line of Brockton Avenue; thence Westerly and along the Southerly line of 14th Street 47.5 feet to the Easterly line of Brockton Avenue; thence South Westerly and along the Easterly line of Brockton Avenue a distance of 41.5 feet; thence in a North Easterly direction and on the arc of a circle having a radius of 180 feet, and convex to the North a distance of 72 feet more or less to the point of beginning.

WHEREAS, said property is of no use to the City of Riverside and cannot be utilized for the City in any way whatever; and,

WHEREAS, it is for the benefit of the City to dispose of the same; and,

WHEREAS, after due consideration it has been ascertained that the value of the said property is not over Five Dollars (\$5.00); and,

WHEREAS, Oscar L. Harris and Nora Harris are willing to pay the said sum;

NOW, THEREFORE, it is hereby resolved that the said property be sold to Oscar L. Harris and Nora Harris, husband and wife, as joint tenants, for the price of Five Dollars (\$5.00), and that upon payment of the same the Mayor of the City of Riverside and the City Clerk of the said City be, and they are hereby, authorized to sign a Quitclaim Deed therefor.
