That portion of Lot 2 of Am... Map of Indian Hill Tract, as shown by map on file in Book 10, Page 3 of Maps, Records of the Recorder of Riverside County, California, being more particularly described as a triangular parcel of land bounded on the Southeast by the Westerly line of the right of way of the Riverside County Flood Control District, said Westerly line having a bearing of N. 31°31'47" E., as shown by sheet 5 of map of survey on file in Book 26, Pages 88 to 92 of Record of Surveys, Records of said Recorder; bounded Northerly by that line bearing S. 81°42'10" W., from said westerly line, by the line bearing N. 77°51' W., and by the line bearing S. 60°35' W., (said 3 bearings being shown on California State Highway right of way map, File No. 907575, as being, respectively, S. 79°31'48" W., N. 77°57'12" W., and S. 60°28'48" W.); and being bounded Southwesterly by the Northwesterly line of the right of way of State Highway Route 60, as shown by said right of way map.
