TOGETHER WITH all those certain public alleys lying within Block 10, Range 4 of the Town of Riverside as shown by said map.

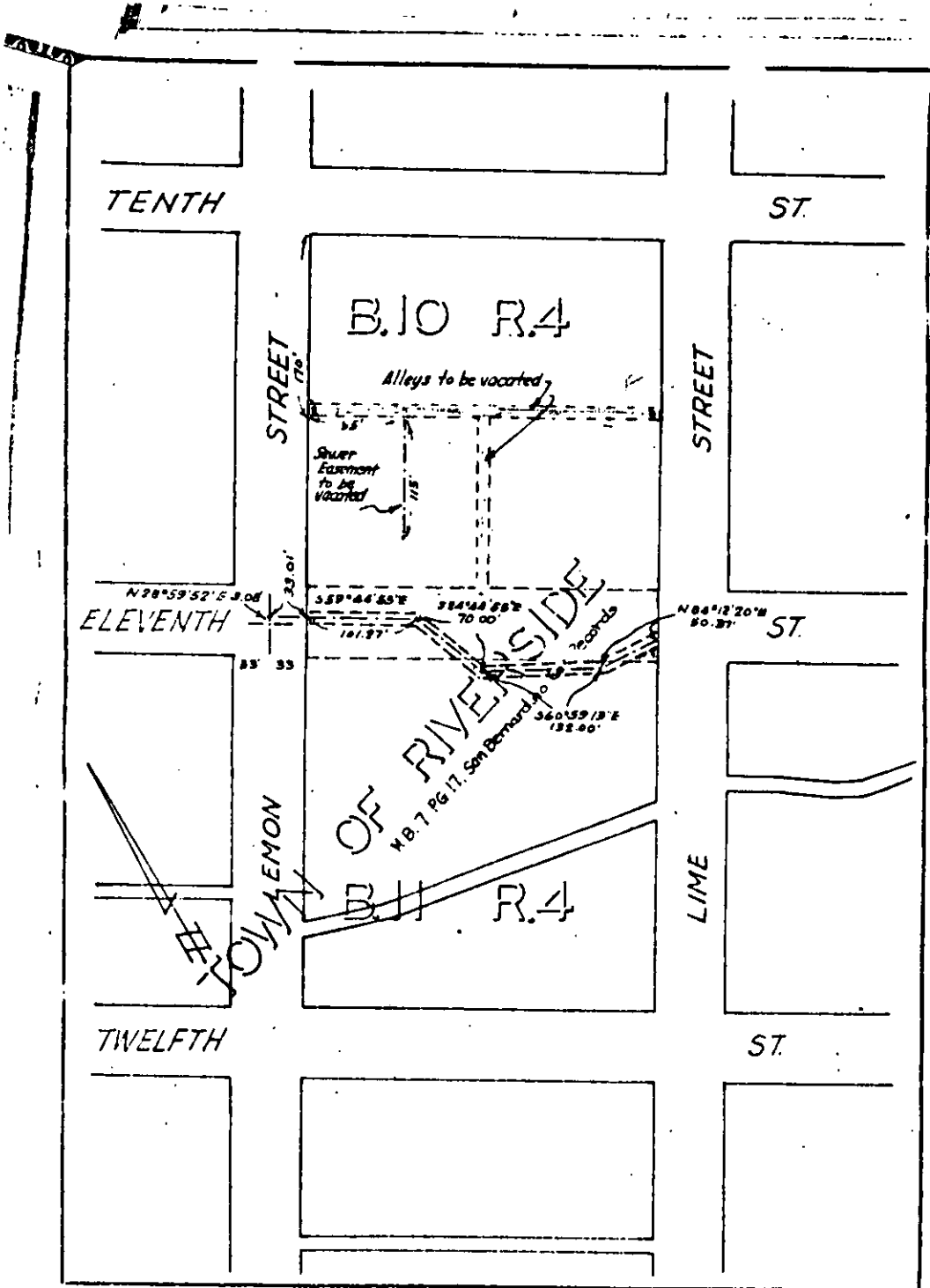
