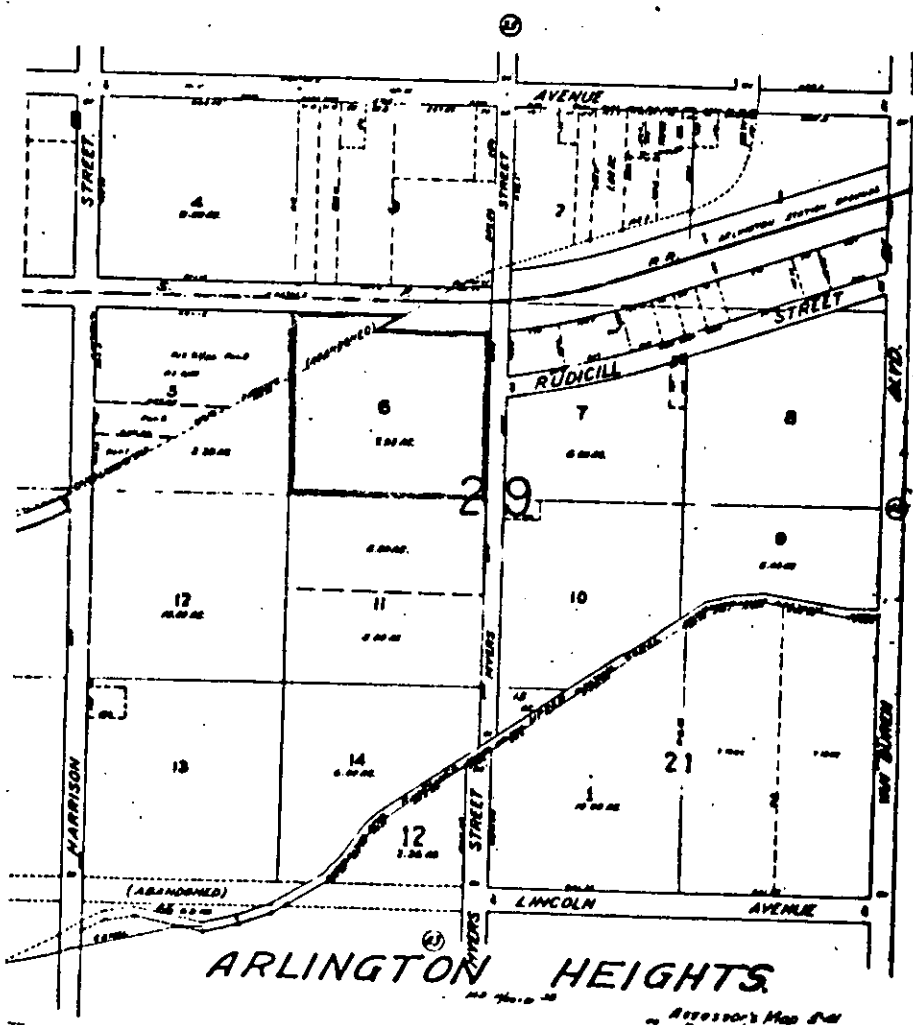

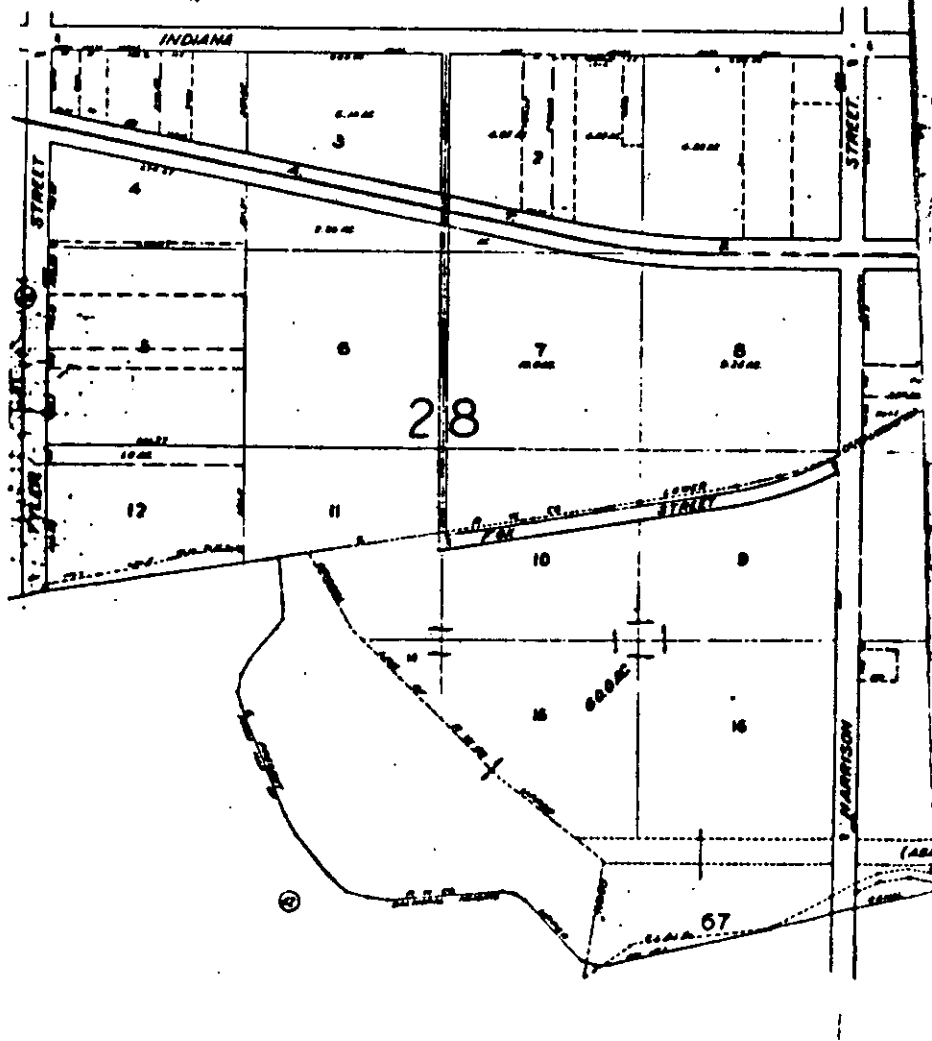
Assessor's Map of
