

RESOLUTION NO. 3157 (NEW SERIES)

O.R. BK. 367-17-158

Resolution declaring that the Closing up and vacating a strip of land lying between Fourteenth Street, Fifteenth Street, Vine Street, and Pachappa Avenue, has been completed.

WHEREAS, the Council of the City of Riverside, did on the 23rd day of February, 1938, pass its resolution No. 3154 (New Series) ordering the work of closing up and vacating a strip of land lying between Fourteenth Street, Fifteenth Street, and Prospect Avenue, hereinafter described, as contemplated by Resolution of Intention No. 3135 (New Series) : and

WHEREAS, the Superintendent of Streets of said City has reported to said Council that the work of closing up and vacating said strip of land lying between Fourteenth Street, Fifteenth Street, Vine Street and Pachappa Avenue, has been done and completed.

NOW THEREFORE, be it resolved that the Council hereby determines that that certain strip of land lying between Fourteenth Street, Fifteenth Street, Vine Street, and Pachappa Avenue in said City, hereinafter described, is closed up and vacated.

That certain strip of land lying between Fourteenth Street, Fifteenth Street, Vine Street and Pachappa Avenue, hereinabove referred to is declared as follows, to-wit:

All that certain real property situate in the City of Riverside, County of Riverside, State of California, described as follows:

All that portion of Lot "A" as shown by map on file in Book 4 of Maps, page 85, Records of Riverside County, California, described as follows:

Beginning at a point on the Southerly line of 14th Street, 270 feet West from the Westerly right of way line of the Union Pacific Railroad, thence South $28^{\circ} 59'$ West, 660.20 feet to a point on the Northerly line of Fifteenth Street; thence South $61^{\circ} 0'$ East, along the Northerly line of Fifteenth Street, 35.0 feet; thence North $28^{\circ} 59'$ East 660.20 feet more or less to a point on the Southerly line of Fourteenth Street; thence North $61^{\circ} 0'$ West, along the Southerly line of 14th Street; 35.0 feet to the point of beginning. SAID POINT OF BEGINNING being also the Northeasterly

corner of Harrington's Tract as more fully shown on map on file in Book 7, page 7 of record of Surveys, Records of Riverside County, California.
