QUITCLAIM DEED

FOR VALUABLE CONSIDERATION, receipt of which is hereby acknowledged, the CITY OF RIVERSIDE, a Municipal Corporation, as successor in interest to California Electric Power Company, does hereby remise, release, and forever quitclaim to PARK <sup>21</sup> ATLANTA/ASSOCIATES, a California limited partnership, the real property in the City of Riverside, County of Riverside, State of California, described as follows:

All that certain easement for the electric distribution facilities, as conveyed to California Electric Power Company, by a deed recorded March 11, 1955 as Instrument No. 16084 of Official Records of Riverside County, located in Lot 1 and in the north half of Lot 7 of the Wilbur Tract, as shown by map recorded in Book 4, Page 36 of Maps, records of San Bernardino County, the center lines of said easement described as follows:

Beginning on the south line of said north half of Lot 7 at a point 247 feet west of the center line of Atlanta Street, and running thence North 11° 35' East, a distance of 50 feet to a point designated and hereinafter referred to as Point "A"; thence north, parallel to and 236.3 feet west of said center line of Atlanta Street, a distance of 419 feet to a point in said Lot 1;

Also beginning at said Point "A" and running thence east, a distance of 35 feet to a point in said north half of Lot 7.

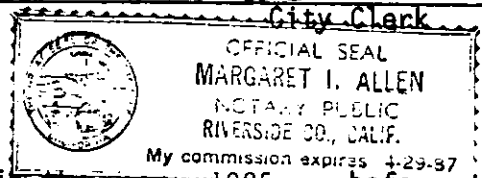

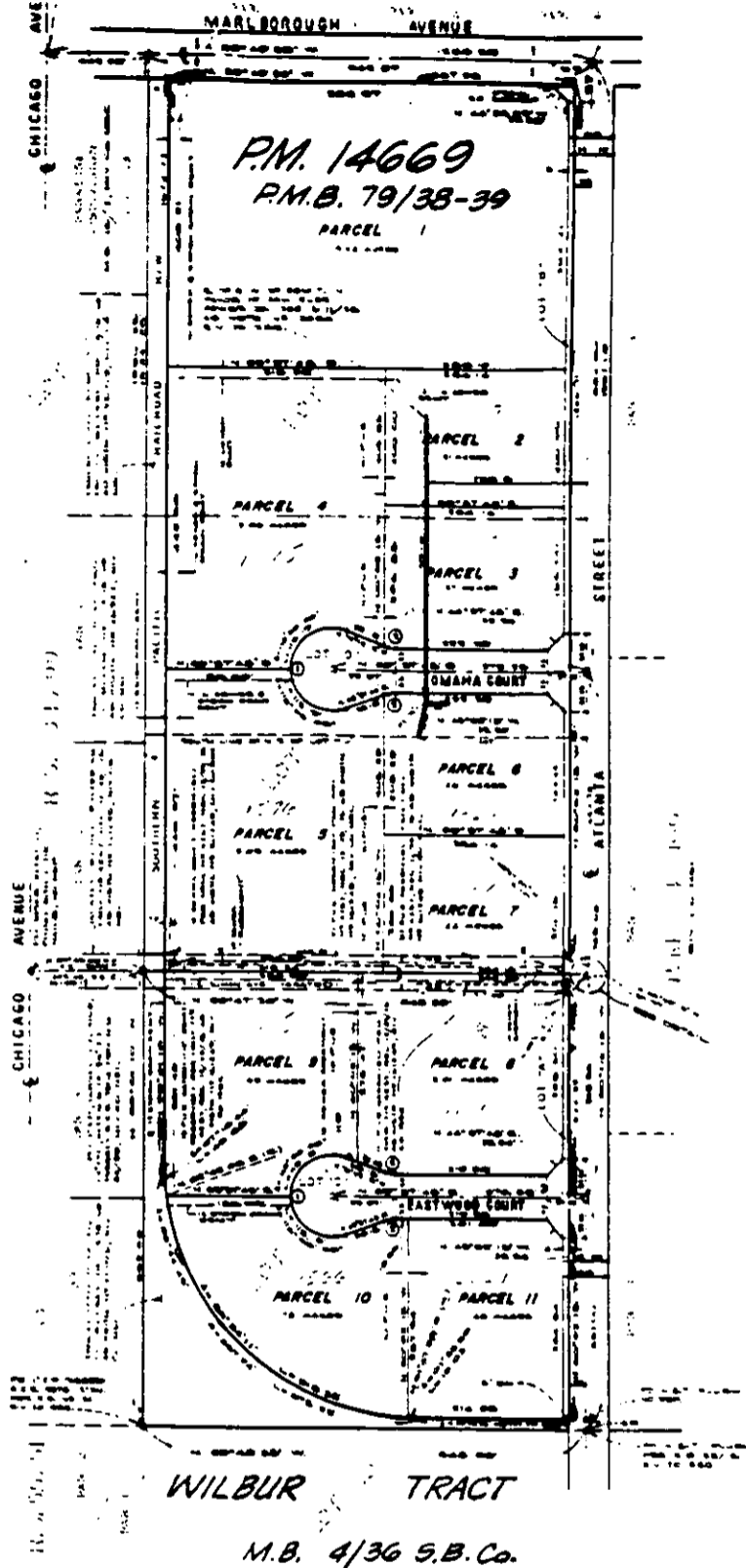
