HANSEN, JR. and SANDRA K. HANSEN, husband and wife as joint tenants, the real property in the City of Riverside, County of Riverside, State of California, described as follows:

That certain easement and right-of-way for roadway purposes, 16.5 feet in width, granted to the City of Riverside by Agreement recorded May 29, 1964 in Book 3707, Page 293, et seq., of Official Records of said Riverside County, being within Parcel 1 of Parcel Map No. 15,257, on file in Book 98, Page 53 of Parcel Maps, records of said Riverside County, said right-of-way overlying that road right-of-way conveyed to Southern California Gas Company and Southern Counties Gas Company of California by deed recorded March 14, 1951 in Book 1252, Page 504 of Official Records of said Riverside County, the center line of said right-of-way being more particularly described as follows:

BEGINNING at a point in the northerly line of Section 24, Township 3 South, Range 5 West, San Bernardino Meridian, distant thereon South 89° 26' 15" West, 332.24 feet from the northeast corner thereof;

THENCE South 66° 35' West, 139.60 feet;

THENCE South 85° 32' West, 155.00 feet;

THENCE South 70° 08' West, 48.10 feet to a point in the westerly line of the north 330 feet of the east 660 feet of said Section 24, distant thereon South 0° 05' 30" West, 80.68 feet from the northwest corner thereof.

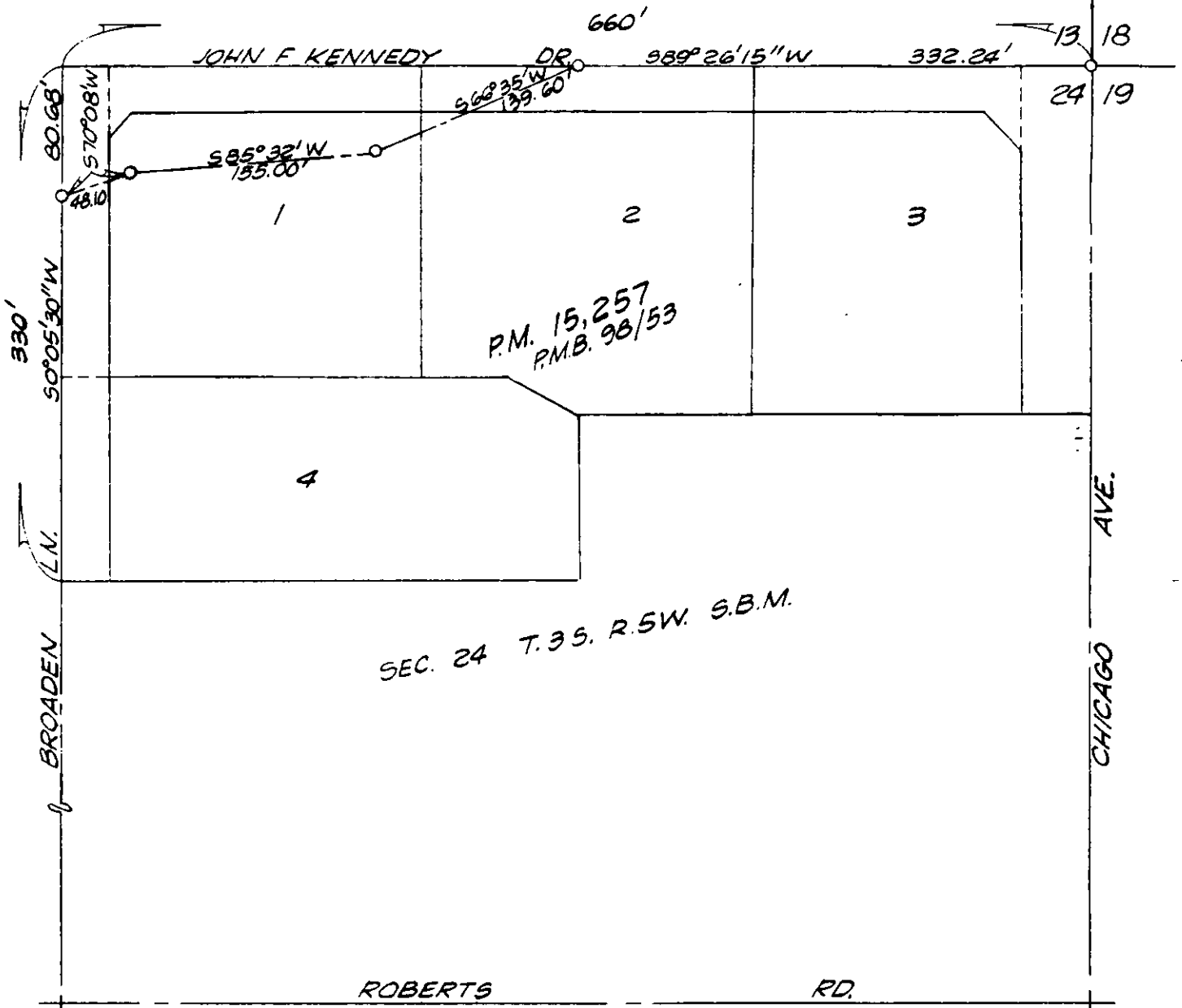
