FOR VALUABLE CONSIDERATION, receipt of which is hereby acknowledged, the CITY OF RIVERSIDE, a municipal corporation, does hereby grant to MAX L. CARDEY and HELEN CARDEY, husband and wife as community property,, the real property in the City of Riverside, County of Riverside, State of California, described as follows:

Lot 9 in Block 16 of White's Addition, as shown by map on file in Book 6 of Maps, at Page 48 thereof, records of San Bernardino County, California together with Lot 9 in Block 3 of Santa Fe Tract, as shown by map on file in Book 6 of Maps, at Page 14 thereof, records of San Bernardino County, California.

EXCEPTING from said Lot 9 of White's Addition and from said Lot 9 of Santa Fe Tract, those portions lying northwesterly of the following described line:

COMMENCING at the intersection of the centerline of Park Avenue with the centerline of Tenth Street as shown on said map of White's Addition;

THENCE North 60° 55' 29" West, along said centerline of Tenth Street, 464.38 feet;

THENCE South 29° 04' 31" West, 33.00 feet to a point in the northwest line of said White's Addition and the True Point of Beginning;
