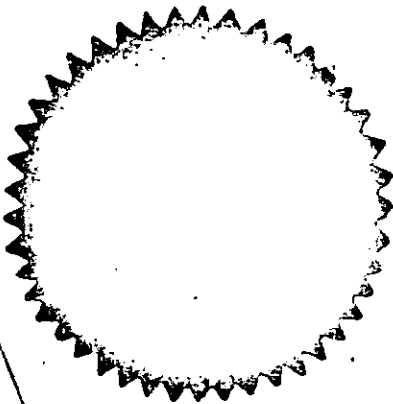

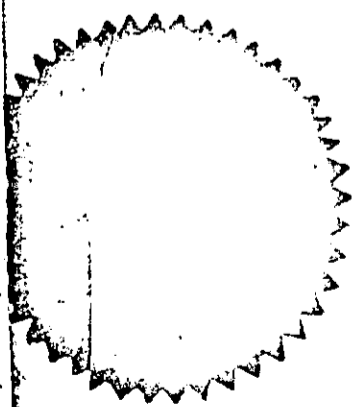

be, and the same is hereby, accepted; and




