THIS INDENTURE, made and entered into this 26 day of March 1940, by and between Henry Whipple and Gwynn Whipple, his wife, first parties, and the City of Riverside, a municipal corporation, second party;

WITNESSETH:

That for and in consideration of the sum of One and no/100 (\$1.00) Dollars, the first parties do hereby grant, bargain, sell and convey to the second party, a right-of-way for the construction and maintenance of a storm water conduit, together with the right of ingress and egress, for the purpose of maintaining, repairing and replacing the same, over and across the following described property:

Situate in the City of Riverside, County of Riverside, State of California, more particularly described as follows:

Beginning at the Northeast corner of Lot 244, Southern California Colony Association Lands, as recorded in Book 7 of Maps, at Page 3 thereof, Records of San Bernardino County, California; thence Southerly along the Easterly line of Lot 244, a distance of 10.00 feet; thence Westerly parallel to the Northerly line of Lot 244, a distance of 412.50 feet; thence Northerly, parallel to the East line of Lot 244 and 243, Southern California Colony Association Lands, a distance of 20.00 feet; thence Easterly parallel to the Northerly line of said Lot 244, a distance of 412.50 feet to the Easterly line of Lot 243, Southern California Colony Association Lands; thence Southerly along the East line of said Lot 243, a distance of 10.00 feet to the point of beginning.


RESOLUTION OF THE COUNCIL OF THE CITY OF
